

## PUBLIC ANNOUNCEMENT

The Board of Directors of the National Lottery Authority (NLA) wish to announce for the information of the general public that in exercising the powers conferred upon them under Section 7 of the National Lotto Act, 2006, (Act 722), it has approved Licensing Fees and Security Deposits payable by all individual, corporate bodies, Lotto Agents and Writers who wish to operate and participate in NLA approved Banker-to-Banker Lotto in the country.

Similarly, the Board of NLA wishes to inform all its existing accredited Lotto Marketing Companies (LMCs) that the Annual Renewable Licence Fee shall be GHC100.00 per Point of Sale Terminal (POST).

New LMCs shall pay an annual Licensing and Security Deposit as provided in the table below. All LMCs shall also pay an insurance premium of GHC50 per POST.

Registration for Licensing ends on April 30, 2018. Kindly note that there would be no licensing after this date.
