

PRESS CONFERENCE

Good morning good people of Effiduase-Asokore Constituency and all Ghanaians at large. It is with great bitterness, that we (New Patriotic Party Effiduase-Asokore Constituency Youth Wing) want to alert the President, National Party Executives, Regional Party Executives and Constituency Party Executives to know why our District Chief Executive Mary Boatemaa Marfo should be sacked from office and not to think of re-nominating her for her actions and in actions caused the party dearly in the December 2020 general elections which we do not want the party to go through such difficulties in 2024 general elections.

Secondly, Hon. Mary Boatemaa Marfo has done everything humanly possible to bring down the Party in the constituency and the District at large. Her behaviour and attitude includes;

- Keeping foodstuffs and other things meant for polling station executives to aid them in their campaigns during the 2020 general elections.
- The only District Chief Executive who hired tugs and hooligans to attack the same party office that aided her appointment.
- She kept the Personal Protective Equipment meant for distribution to the good people of our district and the party, she only gave them to her cronies, partners in crime and other associates at the time the party needed them for campaign.
- Hon. Mary Boatemaa Marfo has never step foot in the same party office that got her to the position for over two and half years.

Furthermore, Hon. Mary Boatemaa Marfo showed total disrespect, gross insubordinate, to the President during the December 2020 elections. Mary Boatemaa Marfo's criminal act in the Ghana School Feeding Program malfeasances; duplication of schools, Enrollment figures inflated and names of non-existing caterers presented for payment which she was asked to refund an amount of 251,585.50 Ghana Cedis into Bank Of Ghana High Street Accounts, as a result of the fictitious data presented to the secretariat which lead to the dismissal of the former Ghana School Feeding Program National Coordinator Dr. Kwame Adu-Nsiah in 2018, yet she is still at post. The EOCO and BNI are very much aware of this act. And is only during Hon. Mary Boatemaa Marfo regime that the parliament select committee on audit banned Sekyere East District from embarking on any new project until the assembly's debt is been paid with the former sports minister Hon. Nii Lamptey Vandapure as a member of the committee that came for the audit.

In conclusion, we (New Patriotic Party Youth Wing Effiduase-Asokore Constituency) would like to use this platform to inform the Presidency, National Executive Council of the New Patriotic Party, the Regional Party Executives of the New Patriotic Party and the Constituency Party Executives that Hon. Mary Boatemaa Marfo is not the right person to be nominated as the District Chief Executive for Sekyere East District. All her actions and in-actions are dragging the Party's hard earned name and reputation in the district into mud. We want her to be relieved of office with immediate effect to prevent her re-nomination.
